Labour Government Reforms after 1997. The Labour Government after 1997 carried out a number of major constitutional reforms:-Scottish Devolution. Labour was committed to devolution for Scotland. A range of Scottish organisation and political parties had formed a Scottish Constitutional Convention, in 1989, and put together proposals for devolution.

So there were no major constitutional changes under the 1979-97 Conservative governments. However, under Labour there was, between 1997 to 2010, House of Lords Reform, Electoral Reform, Devolution & Regional Government, a Bill of Rights (Human Rights Act), a Freedom of Information Act, more use of referendums, and a Constitutional Reform Act setting up the UK Supreme Court and increasing the independence of the Judiciary.
