Competition Law. Current UK competition law is modelled on that of the EU. The Chapter I and Chapter II Prohibitions of the UK Competition Act 1998 (which prohibit anti-competitive agreements and the abuse of a dominant market position) mirror the prohibitions contained in Articles 101 and 102 of the Treaty on the Functioning of the European Union, although there does not need to be a possible effect on trade between EU Member States for the UK prohibitions to apply.
